We do not sell or rent your data.

Some third-party tools (like HeyGen)

may process data outside the UK or EU. We ensure such transfers comply with UK/EU GDPR, typically via Standard Contractual Clauses (SCCs) or equivalent protections.

#### 7. Data Retention

We retain data for the duration of your project and for up to 6 years afterward (for legal and audit purposes). Video content and likeness-related materials may be deleted earlier upon request, unless required by law.
